Payments by mail must be postmarked no later than the "Delinquent after" date and addressed to the Delaware County Treasurer, 100 W. Main Street, Muncie, Indiana 47305. The penalty for late payment of current tax is 10% per installment. For your convenience most county banks and credit unions have agreed to accept property tax payments. Return both 'Spring' copies when paying first installment and both 'Fall' copies when paying second installment. Make all checks and money orders payable to "Delaware County Treasurer". Questions concerning your tax statements should be directed to the Delaware County Treasurer. Failure to receive tax statement by mail does not relieve taxpayer of his responsibility for payment and penalties when delinquent. Tax statements for both installments are enclosed. No separate statement will be sent in advance of the due date of the second installment. Notify the County Auditor of any changes that would effect the status of your exemptions. If receipt desired...please send stamped self-addressed envelope. If total tax liability is less than \$25.00 the total amount is due by date of first installment, Public Law '61, Acts of 1991. "...a property tax liability of less than five dollars (\$5) is increased to (\$5). The difference between the actual liability and the five dollar (\$5) amount that appears on the statement is a statement processing charge. The statement processing charge is considered a part of the tax liability."
